


Cascade's Resiliency Project Is Launched

Building off the successful work of the Water Supply Forum in its efforts to be prepared for future challenges like earthquakes and water quality issues, Cascade launched its resiliency program with its members June 9 at the Meydenbauer Center in Bellevue. Board members, who are elected officials, got a full briefing on the risks of earthquakes, the potential impacts to utilities, communities and the economy, and what federal, state and municipal services they might or might not be able to offer in response and recovery. Cascade and its members are considering how to implement next steps.

Cascade Submits Input on Proposed Reclaimed Water Policy



After reviewing the State Department of Ecology's draft rule language on reclaimed water, Cascade joined with the Washington Water Utilities Council (WWUC) in proposing that water utilities have real input and involvement in decisions to achieve a truly comprehensive regulatory program. They asked that the state involve drinking water utilities, municipal water suppliers and water supply entities in the decision making process; require planning coordination; create a structure to address potential adverse impacts of reclaimed water marketing and use, and bring the reclaimed water product into the established system of coordinated water utility service areas and infrastructure planning.

Lake Tapps Community Open House Draws Large Crowd



More than 100 residents attended Cascade's Thursday, May 16, community open house at North Tapps Middle School. They met with Cascade and other agencies that work around the lake discussing licensing, milfoil, native vegetation, fish, safety in and around the reservoir, water quality, septic tanks, parks, a safe swimming environment, emergency sign locators and other aspects of Lake Tapps life.

Update on Mud Mountain Dam Fish Passage Project



The Mud Mountain Dam Fish Passage Project (MMD FPP) received a "new start" approval and funding for Fiscal Year (FY) 2017 (ending Sept. 30, 2017). Funds are expected in the Seattle District by the end of June which will allow the USACE to finalize real estate offers for Cascade and the Muckleshoot Indian Tribe and complete other pre-construction activities (final design and bid package). The USACE is developing a revised project delivery schedule.

The USACE initially requested \$22.35 million construction funding in the FY 2017 Budget. No funds were authorized. However, the Budget provided for the USACE to develop a work plan to include up to six new construction starts. The MMD FPP was one of these projects. FY 2017 funding totals \$16.4 million (\$7.35 for pre-construction activities and \$9.05 million for initiating construction). The USACE has indicated that the amount for pre-construction activities is sufficient to complete all outstanding tasks. While no construction will begin in FY 2017, construction general funds carry over into future fiscal years. If there were no construction funds available in FY 2017, the USACE would not be able to issue the bid package or make formal real estate acquisition offers.

The proposed FY 2018 Budget (beginning Oct. 1, 2017) includes \$33.6 million for construction.
